Payment of the excess charge shall be made either by cheque, bankers draft, money order or postal order which shall be delivered or sent by post so as to reach THE CITY TREASURER'S DEPARTMENT, CITY CHAMBERS, QUEEN STREET, OXFORD OX1 1EN.

not later than the fourteenth day following the day on which the excess charge was incurred, or in cash in person or by messenger at the said department within the same period, provided that if the fourteenth day falls on a day on which the offices are closed, the period within which payment of the excess charge shall be made to the Council shall be extended until 4.00 p.m. on the next full day on which the offices are open.

IN NO CIRCUMSTANCES SHOULD THE EXCESS PARKING CHARGE BE PAID TO AN ATTENDANT, POLICE CONSTABLE OR TRAFFIC WARDEN.

It is an offence under section 35(4) of the Road Traffic Regulation Act 1984 for the driver of a vehicle who has left the vehicle in a parking place to fail duly to pay the excess charge. FAILURE TO PAY THE EXCESS CHARGE IN THE PERIOD PRESCRIBED MAY RENDER THE DRIVER LIABLE TO PROSECUTION AND A FINE NOT EXCEEDING £50.00 IN ADDITION TO THE EXCESS CHARGE.
