- + (01) The vehicle was waiting in a restricted street—in a parking zone.
- + (1A) The vehicle was waiting in a restricted street—not parking zone or clearway.
- + (1B) The vehicle was waiting in a restricted street—clearway.
- \* (02) The vehicle was left in a parking place, the initial charge not having been duly paid.
- \* (03) The vehicle was left in a parking place for more than the permitted period after the excess charge was incurred.
- \* (04) The vehicle was left in a parking place before the expiration of one hour after it had been taken away from a parking bay in that parking place.
- \* (05) The vehicle was of a class of vehicle not authorised to be left in the parking place.
- \* (06) The vehicle was waiting in a parking place elsewhere than in a parking bay/parking space.
- + (07) The vehicle was of a class of vehicle not authorised to be left in the free parking place.
- \* (08) The vehicle was waiting in a parking place where a hood over a meter indicated that use of the bay was suspended, or a traffic sign indicated that waiting by vehicles was prohibited.
- + (09) The vehicle was waiting in a free parking place where a traffic sign indicated that waiting by vehicles was prohibited.
- + (10) The vehicle was waiting in a free parking place elsewhere than in a parking space.
- + (11) The vehicle was stationary on a cab rank.
- + (14) The vehicle was stationary on the carriageway of a street where vehicles were prohibited from stopping—clearway.
- (15) The vehicle was left in a parking place, the charge not having been duly paid.
- + (16) The vehicle was left in a free parking place during the permitted hours for a continuous period of more than two hours. (London Borough of Ealing only).
- + (17) The vehicle was stationary on a bus stop.
- + (18) The vehicle was left in a free parking place during the permitted hours before the expiration of one hour after it had been taken away from the same parking place during the permitted hours. (London Borough of Ealing only).
- (19) The vehicle was parked in an urban road in Greater London with one or more of its wheels resting on a footway, land between two carriageways, grass verge, garden or space. (Section 15, Greater London Council (General Powers) Act, 1974).

- (20) The vehicle being a commercial vehicle was waiting in a restricted street.
- \*\* (21) The vehicle was on a road during the hours of darkness without the lamps required to be fitted being kept lit. (Regulation 21 Road Vehicles Lighting Regulations 1984).**
- (22) The vehicle was left unattended elsewhere than in a place for the time being appointed for the purpose. (Parks Regulation Acts, 1872 and 1926.)
- (23) The vehicle was waiting elsewhere than in a place for the time being appointed for the parking of a vehicle of its description. (Parks Regulation Acts, 1872 and 1926.)
- \*/+ (24) The vehicle was left in a parking place without there being a valid permit/parking card/disabled person's badge in force and displayed as prescribed.**
- \* (25) The vehicle was left in a parking place without payment of the charge indicated by a parking token duly affixed to a valid permit/parking card displayed on the vehicle/by the display on the vehicle of a valid season ticket/ daily ticket.**
- + (26) The vehicle was left in a parking place where there was a traffic sign 'Diplomatic Cars Only'.**
